PROCUREMENT FOR THE RECTIFICATION OF THE CHILLED WATER PIPE LAGGING FOR DISTRIBUTION CENTRE AT DUBE TRADEPORT AGRIZONE

Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC has a chilled water piping system, which was commissioned in early 2012. The lagging insulation has proved to be inadequate as it is always saturated with water causing leaks into the ceiling voids. The existing chilled water / glycol lines comprise of uPVC piping with polysterine insulation/ lagging. The thickness of lagging varies between 40mm and 100mm.

DTPC wishes to appoint a competent service provider to remove the existing lagging and to supply, install the new insulation/ lagging for the chilled water pipe system.

Only CIDB registered contractors with active status CIDB grading level of 4ME or higher will be eligible to tender.

The contract will have an element of Enterprise Development (ED) and pre-qualification criteria, which requires that bidders sub-contract a minimum of 30% of the contract to an Exempted Micro Enterprise (EME) or Qualifying Micro Enterprise (QSE) company.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference point system where 80 points will be reserved for price only and 20 points reserved for preference points as per the B-BBEE verification certificates.

The DTPC will only release documents once the payment has been cleared in its bank account.
